In view of the above, all concerned are requested to avail this facility by registering adequate number of Railway Wagon Demands for evacuating the existing cargo from VPT and its terminals stack yards and also to facilitate accommodating cargo received from vessels in pipe line.

In terms of Board's Rates Master Circular referred above, Rates of Busy Season Charge, Development Surcharge and Congestion Charge have been notified.

Coal & Coke, Container traffic and Automobile traffic moved in NMG, BCACM, BCCNR & BCACBM wagons are already exempt from levy of Busy Season Charge under extant policies.

The matter has been further reviewed and Competent Authority has decided to withdraw the levy of Busy Season Charge for all commodities, except Iron Ore and POL traffic, till further advice.

All other Terms & Conditions mentioned in above referred Rates Master Circular shall continue remain the same.

Zonal Railways shall maintain loading & earnings data on transportation of commodities without levy of Busy Season Charge and furnish report thereof on fortnight basis.

These instructions shall come into force with effect from 01.10.2019.
