
Sub: Compulsory wearing of PPE while entering the dock premises and other operational areas
Ref: This office earlier circular No. 657, dt. 18.7.2016.

With a view to avoid accidents and injury/loss of human life to the cargo handling personnel as well as those associated with allied activities inside the Port and other operational areas, it was requested to the Users vide the aforesaid Trade Circular to ensure compulsory wearing of PPE by their workmen and supervisors engaged in such operation.

However, it is noticed that compliance of the aforesaid is very poor which has culminated into increase in accidents and near misses. The aforesaid safety lapses have been viewed very seriously by the Dock Safety Authorities and under the circumstances it has been decided by the Appropriate Authority of VPT not to allow entry of any personnel inside the port premises and other operational areas without proper PPE. CISF personnel posted at the gates will therefore not allow entry of such personnel without PPE w.e.f. **01.09.2018.**

All concerned are requested to co-operate in the matter for safety of personnel working in operational areas.


