In continuation of this office circular 2<sup>nd</sup> cited and with reference to Dy. Conservator letter 3<sup>rd</sup> cited, it is to mention that Panamax vessels with Draft 12 mts. and Handymax vessels with Draft 12.5 mts can be handled at WQ3 berth during day light hours with required tide in calm weather conditions, in addition to EQ-1, WQ1 and WQ2 berths, mentioned at circular 2<sup>nd</sup> cited. However, the draft of Panamax Vessels will be gradually increased to 12.5 Mts.

In view of the above, it is requested to nominate vessels accordingly.
