CIRCULAR - 751

Sub:- Remission of amounts as an incentive to Port users moving Dry Bulk Cargo by Open top Railway Wagons – Reg.

Ref 1:- This Office Circular-747 vide Lr No:ITRA/ROC/FTC Dt 24-03-2017.

Ref 2:- Board Resolution No: 186/2016-17 in respect of Agenda Item No S-18 during the VPT Board Meeting No: 5 of 2016-17 of the Board of Trustees of VPT held on 18.03.2017 at the Port Trust Board Room, circulated vide General Administration Department Lr No: IGAD/BDS/BM-5/2016-17, Dt: 03-04-2017.

Reference is invited to this office Circular 1st cited, wherein the revised Railway Terminal Charges effective from 01-04-2017 to 31-03-2019 was circulated.

However, in view of the heavy competition being faced by VPT and in view of the general impression among the users that the handling costs in VPT continue to be at a high level substantially, the Board vide resolution 2nd cited resolved to continue to give a remission w.e.f 01-04-2017, under Sec.53 of MPT Act for Consignees as mentioned in the RRs (chargeable tonnage) issued by VPT for all types of dry bulk cargoes loaded into Open Top wagons (outward rail traffic) for all types of dry bulk cargo that has been discharged at any of the berths – VPT owned / BOT owned and loaded at VPT terminals / sidings / BOT premises at the following rates:

- 1) A flat upfront rate of Rs. 11.50 per M.T.
- 2) Once the Consignee handles atleast 20% or more of outward railway traffic (as described above) as compared to that handled in the previous financial year 2016-17, a further Rs. 11.47 M.T for all the above mentioned type of rail bound cargo handled by the consignee during the entire financial year 2017-18 and
- 3) The above benefits are effective for the financial year 2017-18.

In view of the above, all the Rail Users are requested to note the same.
