Vide the referred letter it was communicated that, Visakhapatnam Port Road Co.Ltd (VPRCL), wherein it was informed that, the maintenance activity of port connectivity road form Convent Junction to Sheelanagar i.e., from Km.0.000 to Km 10.336 including Ramps has been undertaken by the O&M Contractor M/s.Krishna Construction and the cleaning of entire project Highway is a routine activity which is being performed by the O&M contractor.

Further, the VPRCL informed that, on several instances, the substances such as petroleum products, iron ores, chemicals, marble clinker, debris etc are found strewn on the road by the cargo carrying heavy vehicles, due to leakage or carrying load beyond the prescribed limit.

They also stated that, although the O&M Contractor undertakes regular cleaning of road and ramps, the above stretch found to be dirty and the O&M Contractor has brought this to the notice of CFO & Project Director of VPRCL and requested to stop the vehicles with over loading which are spilling out material on the road rendering hazardous conditions to the road users, as well.

In view of the above, it is requested to ensure that the cargo carrying vehicles are not overloaded and are leak proof, as the spillage of cargo is a matter of serious concern to road safety.

Therefore, it is requested to take necessary action and for strict compliance.
