TRADE CIRCULAR No.1580

Sub: Grant of License for supply, installation, testing, commissioning, operation and maintenance of 02(two) nos. of Harbour Mobile Cranes (HMCs) of capacity not less than 100 MT for deployment in the inner harbor of Visakhapatnam Port Authority- Implementation of New tariff with revised OSBD- reg.

The Board of Visakhapatnam Port Authority in the meeting held on 19.01.2023 vide Agenda item No.R4, its Resolution No.104/2023-23 resolved with regard to New tariff with revised OSBD for the cargos handled by HMCs installed at VPA berths as follows:

(i) For Dry Bulk Cargo

Note; to calculate the incremental ceiling rates as shown above, the base rate was enhanced to 105% for first thousand tonnes and for the 2nd thousand tonnes the rate was enhanced to 110% of the base rate. The same methodology shall be adopted to calculate the rate beyond 17000 tonnes.

(ii) For Break Bulk Cargos

Average daily crane performance (in Metric Tonne)	Ceiling rate per tonne (in Rs.)

7200	135.53	81.32
7201-8200	142.30	85.38
8201-9200	149.08	89.45

Note; to calculate the incremental ceiling rates as shown above, the base rate was enhanced to 105% for first thousand tonnes and for the 2nd thousand tonnes the rate was enhanced to 110% of the base rate. The same methodology shall be adopted to calculate the rate beyond 9200 tonnes.

(iii) For other cargos

4501-5500	227.69	136.61
5501-6500	238.53	143.12

Note; to calculate the incremental ceiling rates as shown above, the base rate was enhanced to 105% for first thousand tonnes and for the 2nd thousand tonnes the rate was enhanced to 110% of the base rate. The same methodology shall be adopted to calculate the rate beyond 6500 tonnes.
