IPA vide letter 2nd cited communicated to index SOR/VPA for the year 2023-24, effective from
1st May 2023 and valid till 30th April 2024.

Accordingly, VPA is entitled for 12.12% annual indexation of the Scale of Rates for the year
2023-24 effective from 1st May 2023 for the following services,

- 1) All Vessel Related Services
 - 2) All Cargo Related Services [except for cargoes which not achieved the performance
standards i.e Fertilizers (Mech), Sulphur (Mech), Rock phosphate(Mech), Fertilizer(Conv),
Transshipment Crude (MT +DT)] & Imp. POL-OH]
 - 3) All miscellaneous services.

- 4) For cargoes which not achieved the performance standards i.e Fertilizers (Mech), Sulphur
(Mech), Rock phosphate(Mech), Fertilizer(Conv), Transshipment Crude (MT +DT) & Imp.
POL-OH on which 60% indexation (i.e 7.27%) is entitled.

Applicable indexation as stated above is applicable on the Scale of Rates in force as on date.
The new rates are in the process of notification and as and when it is notified and comes into force, the
said rates will be inclusive of indexation i.e indexation shall be applicable on the new rates published in
the VPA website on dt.27.03.2023 as stated above from the date it comes into force.
