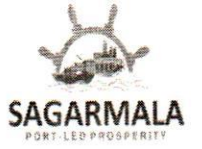

TRADE CIRCULAR - 1649

Sub: NHA, PIU, Visakhapatnam-Improvement works for Visakhapatnam Port Road- Rehabilitation of(i) Nehru Centenary Flyover(NCFOB) (ii) Ambedkar Centenary Flyover(ABFOB) (iii) Ramp- A Flyover - Traffic diversion for execution of rehabilitation work.-Reg.

Please refer the Circular cited regarding the subject work and it is to reiterate that the subject rehabilitation work was taken up by NHA and accordingly the contractor has been taken up the work w.e.f: 05-04-2023.

To execute the subject work, there shall be a traffic block in the time slot from 21:00 hrs to 06:00hrs of every day from 01st October 2023, duly diverting the traffic through C-Ramp of new flyover bridge by allowing two way traffic and by opening the toll plaza gates near Y Junction during the traffic period of about 3 months.

Accordingly, support of the Trade is solicited during the above diversion of traffic till the time of completion of critical part of rehabilitation work, in view of the safety of the road users and to avoid untoward incidents.

In light of the above work taken by NHA co-operation from Trade is kindly solicited to provide necessary support for traffic diversion for the early completion of work .
