The tenderer who wishes to upload the tender documents from the VPA website (<http://www.etenders.gov.in>) and meet the following criteria. Details of average annual turnover shall not be less than 30% of the estimated amount put to tender during the last 3 (three) years ending 31st March of the previous financial year, duly certified by the Chartered Accountant. Proof of experience in similar nature of works i.e., experience of having successfully completed Civil works during last 7 years ending last day of month previous to the one in which applications are invited should be 3 (three) completed Civil works each costing not less than the amount equal to 40% of the estimated amount put to tender (or) 2 (two) completed Civil works each costing not less than 50% of the estimated amount put to tender (or) one completed Civil work costing not less than 80% of the estimated amount put to tender. If the delay attributable to the contractor in execution of any completed work is more than 25% of contract period, they will not be short listed and price bids will not be opened. Proof of registration as a registered contractor with Govt. / PSU or with VPA or other organization is not to be treated as eligibility criteria. All the eligible Bidders, who are registered with **NSIC/Ministry of MSME**, are exempted from payment of EMD amount and tender Document Cost subject to fulfilling of conditions detailed in Tender Document. The tenderers may keep a watch for further amendments if any at <http://www.etenders.gov.in> before submitting the bids and any further clarifications can also be obtained from CE's office VPA. In case of any inconsistency between conditions in the document/ amendments/corrigendum / clarifications, the decision of the Engineer-in-charge shall be final.

The tender documents that are uploaded online on VPA e-procurement website (<http://etenders.gov.in>) will only be considered for bid evaluation.

**Note:** (1) The bidders should pay the Transaction Fee (non-refundable) and EMD in online through etenders portal only. Further, the bidders shall upload the copy of the online transaction details with UTR No. along with the Technical bid documents failing which the bid shall be summarily rejected. (2) In case of the NSIC/MSME certificate submitted bidders, the eligibility for exemption of Transaction fee and EMD amount subject to fulfilling of tender condition. (3). Port will not accept the payment of transaction fee and EMD through DD/RTGS/NEFT/Net banking etc., and such bids will not be considered for bid evaluation. (4). **Provisional turnover will not be considered for evaluation.**
