In continuation to the referred circulars, review was done for fixing per tonne rate for recovering the cost of Wagon Damage & Deficiency charges, based on Terminal / system of Wagon Operation, for the period from October-2023 to December-2023 and following is the per tonne rate.

In respect of Heavy Repair (HR) and Derailed wagons, etc, the Damage & Deficiency charges will be collected from Port users, where applicable on the basis of actual damage cost, claimed by Indian Railways in the monthly Damage & Deficiency bill.

It is to reiterate that the rate per tonne mentioned above will be effective from 01.10.2023 to 31.12.2023, after which the same will be reviewed based on the cost of damages and other charges payable to E.Co.Railways by VPA, in actuals. Any shortfall in the amount collected based on the "Per Tonne Rate" will be included in the subsequent bills, on per MT basis, for arriving at "Per Tonne Rate" in the subsequent bills.

All Port Rail Users are accordingly requested to maintain sufficient funds balance in their respective Port Deposit Accounts. Further, it is also requested to exercise utmost caution during handling the wagons to avoid damages, so that the next revision of the rates can facilitate in reduction of the per tonne rate.
