Sub: Risk Based Random Inspection System (RBRIS) - Compliance of requisite information for Workers (Safety, Health and Welfare) Act,1986—reg

Ref: Dy.Director General & Chief Inspector of Dock Safety, Mumbai Lr.No.DS-Enf/3/2023-HQ-Mum dated 2-11-23

The Government of India has ratified the ILO-C 81 and the main objective of the above conventions is to establish a system of Labour Inspection to secure the enforcement of Legal provisions relating to condition of work and protection of workers while engaged in their work.

In this context, DGFASLI, Ministry of Labour & Employment, Government of India has taken initiative to develop the Risk Based Random Inspection System (RBRIS) for enforcing Dock Workers (Safety Health and Welfare) Regulation 1990 framed under the Dock Workers (Safety, Health and Welfare) Act,1986 in the Major Ports of India as a proactive measure. This system will help in achieving the statutory compliance without hindering the flow of cargo handling in Ports.

In this regard, they informed that the Risk Based Random Inspection System (RBRIS) proforma as enclosed is to be filled up and duly filled -in proforma is to be forwarded to Directorate at the email-id: rbrs-ids@dgfasli.nic at least 48 hrs prior to arrival of the vessel(s) in Port.

Hence the Port Users (i.e., Agents seeking movement of the vessel) are requested to submit the filled up the Proforma and sent to the Directorate on email-id <u>rbris.ids@dgfasli.nic.in</u> at least 48 hrs prior to the arrival of the vessel (s) to port.

A copy of the same shall be enclosed to the vessel checklist submitted to this Office for reference and record and to accord movement to the subject vessel.
