Upper age limit is relaxable to the extent of 03 Years for OBC candidates and 05 Years in the case of ST/SC Candidates will be allowed. The SC/ST candidates have to submit their latest caste certificate. The OBC candidates have to submit the caste certificate regarding their OBC status as well as exclusion from creamy layer in the latest proforma prescribed by the Central Government. The upper age limit is also relaxable for Government Servants as per extent rules. The SC/ST/OBC candidates have to submit the latest caste certificate.

Candidates, if appointed will be governed by the New Pension Scheme, which came in to force w.e.f. 01-01-2004 and other Rules & Regulations of Visakhapatnam Port Authority. Details will be intimated at the time of appointment.

The crucial date for determining the eligibility of the candidates with regard to qualification, experience and age shall be 01.02.2024 i.e. the first day of the month in which the post is notified in terms of Regulations 10 (2) of VPE (RSP) Regulations 2009.

Applications of those already working in Government Service should furnish "NO OBJECTION CERTIFICATE" from their employer along with Copies of ACRs/ APARs for the post five years (2018 – 2023) with attestation by an officer not below the rank of Dy. HOD, Vigilance & Administrative Clearance Certificate, Disciplinary case position for the last 10 years and integrity certificate.

Depending up on the requirement, VPT reserves the right to cancel/restrict/curtail the Recruitment process at any stage or increase / decrease number of posts including device in its own method in selecting the candidates without any further notice and without assigning any reasons thereof.
