The tenderer who wishes to participate shall upload the tender documents to the VPA Website (http://etenders.gov.in) and meet the following criteria. Details of average annual turnover shall not be less than (30% of the estimated amount put to tender) during the last 3 (three) years ending 31st March of the previous financial year, duly certified by the Charted Accountant with UDIN number. Proof of experience in similar nature of **P.Way works** i.e., having successfully completed Civil works during last 7 years ending last day of month previous to the one in which applications are invited should be 3 (three) **P.Way works** i.e., completed each work costing not less than the amount equal to 40 % of the estimated amount put to tender (or) 2 (two) **P.Way works** i.e., completed each work costing not less than 50% of the estimated amount put to tender (or) one **P.Way work** completed work costing not less than 80% of the estimated amount put to tender. Proof of Registration as a registered contractor with Govt./PSU or with VPA or other organization is not to be treated as an eligibility criteria.

If any amendment or addendum will be issued before opening of the tenders and the same may be looked in the website (https://etenders.gov.in) and any further clarifications can also obtained from CE's office VPA.

In case of any inconsistency between conditions in the document/ amendments/ corrigendum/ clarifications, the decision of the Engineer-in-charge shall be final.

<u>Note:</u> (1) The bidders should pay the Transaction Fee (non-refundable) and EMD only in online through etenders portal only. Further, the bidders shall upload the copy of the online transaction details with UTR No. along with the Technical bid documents failing which the bid shall be summarily rejected. (2) In case of the NSIC/MSME certificate submitted bidders, the eligibility for exemption of Transaction fee and EMD amount subject to fulfilling of tender condition. (3). Port will not accept the payment of transaction fee and EMD through DD/RTGS/NEFT/Net banking etc., and such bids will not be considered for bid evaluation. (4). Provisional turnover will not be considered for evaluation.
