- 1 The Contractor has to submit the offer for the same in single cover system and to be submitted on or before the due date duly addressing to the Executive Engineer (Elec.)-II, Visakhapatnam Port Authority.
- 2 According to GST rules, every firm/dealer is liable to be registered, whose turnover exceeds Rs.20 Lakhs for supply of Goods/Services/Executing any work contract.
- 3 Firm's quoted rate shall be exclusive of GST components.
- 4 Payment Terms:
 - a) 100% payment will be made on successful completion, of entire work duly certified by the engineer-in-charge.
 - b) Payment will be made against TAX INVOICE as prescribed under the GST Act/Rules and the supplier/contractor is required to remit GST as per the Govt. Rules and file the details in GSTR1 on or before 10th of the subsequent month to enable VPA to claim input tax credit, otherwise the said tax invoice will be kept pending for payment.
- 5 Validity of offer should be 2 months from the last date of receipt of the offers.
- 6 Statutory deductions will be made from the bills.
- 7 Conditional offers will be rejected.

In this connection, it is proposed to establish new LED Display Cum Logo Sign Board for beautification.

The said work cannot taken-up departmentally due to lack of expertise and materials.

In view of the above, it is proposed to off-load the subject work to an experienced firms to meet the exigency, for which an estimate has been prepared for Rs.93,200/- including GST@18% and contingencies @3% basing on the Earlier W.O. rates.

As per the guidelines of Ministry of Shipping, Govt. of India vide letter No.17011/2005/PG, Dt.11.02.2005, Annexure -2 regarding delegation of enhanced powers of MPT's, CME is competent Authority up to One Crore for sanction of estimates.

The expenditure can be met from the revenue budget estimate under the allocation No.054-590-556.

Therefore Sanction of CME is requested to the following:-

1. To the estimated amount of 93,200/- including GST@18% and contingencies @3% "Supply, Installation, Testing & Commissioning of LED Display Cum Logo Sign Board in front of DCI Building in VPA" under section 93 of MPT Act 1963.
