02 (Two) posts of Executive Engineer (Civil) on scale of pay of Rs.50,000-1,60,000 in Civil Engineering Department of Visakhapatnam Port Authority, are to be filled up by Absorption/Deputation from the officers of Major Port Authorities fulfilling the eligibility criteria prescribed in the Recruitment Rules enclosed, **at Annexure -I.**

Applications are, therefore invited from the eligible and willing officers who satisfy the Recruitment Rule for the post of Executive Engineer (Civil) in the prescribed format enclosed, **at Annexure -II.**

Applications may be forwarded by the respective Port Authorities to the undersigned along with the following documents:


1. Copies of ACRs duly attested by an Officer not below the rank of Deputy HOD on each of the page of the ACR of the applicant for the last five years (up to March, 2023). If ACR for a particular year/period is not available, the certificate to that effect may be attached and the ACR of the preceding years for similar No. of years should be enclosed with the certificate indicating the reasons for non-availability of ACRs.
2. Attested copies of all certificates, as a proof of educational qualification, qualifying service/experience in the respective feeder post & pay scale wise.
3. No Objection Certificate of the Heads of the respective Port /Organization.
4. Administrative clearance of the concerned port as per enclosed proforma.
5. Vigilance/Administrative clearance of the concerned Port in the prescribed proforma as per Ministry's letter No.A12022/10/205-PE-I, dt.27.08.2010, duly filled in all respects.
6. Two latest passport size photographs (to insert/attach in an envelope).
7. **The crucial date to determine the eligibility criteria for 02 (two) posts is 26.07.2024.**
8. Undertaking of the applicants to the effect that candidature will not be withdrawn, if selected.
9. Incomplete application or application received after the due date will not be considered.
10. **The last date for receipt of application duly completed, by the Port Authority is 26.07.2024.** Incomplete application or application received after the due date will not be considered.

If any major or minor penalty has been imposed on the applicant during the last 10 years, the disciplinary case leading to such penalty along with necessary documents may be sent by the forwarding authority along with the application. Vigilance report is to be furnished in the attached format as at **Annexure III.**

The Port reserves the right to cancel or make any alteration in the recruitment process, if need arises, without further notice and without assigning any reason thereof, changes, if any will be notified in Port's website only.
