Sub Mines and Minerals – Details of exporter wise Iron ore Exported through Visakhapatnam Port Trust for the period from 1-4-2019 to 31-12-2023- Not to allow the Exporter without having Mineral Dealer License as per Mineral Dealer Rules 2017-Action –Requested – Reg

Of late, it is observed by District Mines and Geology officer, Department of Mines and Geology, Visakhapatnam vide reference cited, that Most of Exporters have not registered and not obtained any licenses under AP Mineral Dealer rules- 2017 and exported Iron ore through Visakhapatnam Port Authority for the period from 01-4-2019 to 31-12-2023.

Hence, in view of the above it is requested to obtain Mineral Dealer Licenses as required under AP Mineral dealer Rules 2017 from the office of District Mines and Geology officer, Visakhapatnam immediately failing which you are not allowed to Export the minerals through Visakhapatnam port authority
