The tenderer who wishes to participate shall upload the tender documents to the Website(<http://etenders.gov.in>) and meet the following criteria. Details of average annual turnover shall not be less than (30% of the estimated amount put to tender) during the last 3 (three) years ending 31st March of the previous financial year, duly certified by the Chartered Account with UDIN number. Proof of experience in Works i.e., having successfully completed **manning, operation and maintenance of any tug or harbour craft above 200 gt.** for a minimum period of one year during last 7 years ending 31.03.2024 and the value of similar works in which applications are invited should be 3(three) works each costing not less than the amount equal to 40% of the estimated amount put to tender (or) 2(Two) works costing not less than 50% of the estimated amount put to tender. (or) one work costing not less than 80% of the estimated amount put to tender. If any amendment or addendum will be issued before opening of the tenders and the same may be looked in the website (<http://etenders.gov.in>) and any further clarifications can also be obtained from DC's office VPA. The tenderers may keep a watch for further amendments, if any, at <http://etenders.gov.in> before submitting the bids and any further clarification can also be obtained from DC's office VPA. In case of any inconsistency between conditions in the document/amendments/corrigendum/clarifications, the decision of the Deputy Conservator shall be final. The signed tender documents along with all enclosures / accompaniments that will be uploaded online on VPA e-procurement Web-site (<http://etenders.gov.in>) will only be considered for bid evaluation

Note: (1) The transaction Fee(Non-refundable) and EMD shall be accepted only through RTGS/NEFT/Bank transfer etc., The VPA Bank account details to which amount is to be transferred on SBI, Visakhapatnam Port Branch, A/c.No.30387186900 IFSC code-SBIN0001740. Further, the bidders shall upload the copy of the online transaction details with UTR No. along with the Technical Bid documents failing which the bid shall be summarily rejected. (2) In case of the NSIC/MSME certificate submitted bidders, the eligibility for exemption of Transaction fee and EMD amount subject to fulfilling tenders condition. (3) Port will not accept the payment of transaction fee and EMD through DD/Bankers Cheque etc., and such bids will not be considered for bid evaluation. (4) Provisional turnover will not be considered for evaluation
