Sub: Removal of tarpaulin covers dumped at Yerri gedda on road side near
STP entrance channel - Reg.

With a view to comply with the directions issued by Executive Engineer (ENV)/ Civil Engineering department regarding removal of tarpaulin covers dumped at Yerri gedda on road side near STP entrance channel, the department is issuing various circulars to the Trade for compliance of the said directions as issued by Environmental Authorities from time to time.

In this regard, the licensees of various stacking areas allotted on short term license are required to cover all dusty cargoes with good quality tarpaulins for dust suppression. However, such tarpaulins gets frequently torn due to weather conditions and repeated usage.

In light of the above, Trade concerned are requested to dispose such cut & torn /Plastic waste at earmarked area at Yerrigeda wall i.e. opposite to STP only. failing which, necessary prnal action will be initiated as per the existing provisions of VPA.

The matter may please be treated as "MOST IMPORTANT".
