The tenderer who wishes to participate shall upload the tender documents to the VPA Website (<http://etenders.gov.in>) and meet the following criteria. Details of average annual turnover shall not be less than 100% of the estimated amount put to tender during the last 3 (three) years ending 31st March of the previous financial year, duly certified by the Chartered Accountant with UDIN number. Proof of experience in **Geo-Technical investigation works**. i.e., having successfully completed **Geo-Technical investigation works** during last 7 years ending last day of month previous to the one in which applications are invited should be 3 (three) completed **Geo-Technical investigation works**, each costing not less than the amount equal to 40% of the estimated amount put to tender (or) 2 (two) completed **Geo-Technical investigation works**, each costing not less than 50% of the estimated amount put to tender. (or) 1 (one) completed **Geo-Technical investigation works**, costing not less than 80% of the estimated amount put to tender. Proof of Registration as a registered contractor with Govt./PSU or with VPA or other organization is not to be treated as an eligibility criteria. If any amendment or addendum will be issued before opening of the tenders and the same may be looked in the website (<https://etenders.gov.in>) and any further clarifications can also be obtained from CE's office VPA. The tenderers may keep a watch for further amendments if any at <http://etenders.gov.in> .in before submitting the bids and any further clarifications can also be obtained from CE's office VPA. In case of any inconsistency between conditions in the document/ amendments/ corrigendum/ clarifications, the decision of the Engineer-in-charge shall be final. The signed tender documents along with all enclosures/ accompaniments that will be uploaded online on VPA e-procurement web-site (<http://etenders.gov.in>) will only be considered for bid evaluation.

**Note:** (1) **The bidders should pay the Transaction Fee (non-refundable) and EMD in online through e tenders portal only.** Further, the bidders shall upload the copy of transaction fee and EMD of the online transaction details with UTR No. along with the Technical bid documents, failing which the bid shall be summarily rejected. (2) In case of Micro & Small scale bidders having NSIC/MSME certificate, the bidders are eligible for exemption of Transaction fee and EMD amount subject to fulfilling of tender condition. The bidders shall submit the certificates along with technical bid for claiming exemption, failing which the bids will be out rightly rejected. (3). Provisional turnover will not be considered for evaluation.
