- The Board vide its Resolution cited, has approved to frame draft (1)Visakhapatnam Port Authority Employees' (Recruitment, Seniority and Promotion) Regulations 2024 including the Recruitment Rules of Class-I posts superseding the existing Visakhapatnam Port Authority Employees' (Recruitment, Seniority and Promotion) Regulations 2009 and to forward to the Ministry for its approval. On approval of the Ministry for the said Regulations, the same shall be pre-published in the AP Government Gazette as per the laid down procedure before forwarding the proposal to the Central Government for seeking the sanction and notification in the Gazette of India under sub-section (2) (i) of Section 72 of the Major Port Authorities Act 2021.

Gazette, in which the draft regulations are published, are made available to the public.
