Some modifications are made to the earlier Circular under reference cited, hence, Doctors are hereby advised to follow the instructions as mentioned below:

Category A medical beneficiaries :- Patients are eligible for indoor medical facility only at G.J.Hospital i.e., **(a) doctor consultation (b) to use available medicines at GJH pharmacy and to undergo tests at Clinical laboratory & Radiology sections.**

Category B medical beneficiaries :- In addition to the indoor treatment as mentioned above alike Category-A, they are eligible for outdoor treatment also i.e., **outside referrals to empanelled hospitals & diagnostic centres and local purchase of medicines at par with regular VPA medical beneficiaries**



All the doctors are once again directed to check thoroughly the aforementioned details either at out-patient clinic or Casualty and eligibility criteria should be verified before providing treatment. After giving appropriate treatment the concerned medical officer should see that the Xerox copy of medical identity (MI) book cover page along with required details like doctor consultation, investigations done and tablets issued should be submitted by the patient and also clearly mention the details of medicines prescribed (**not to write "repeat all i.e., in shortcut code". The documented details of medical treatment availed by other ports medical beneficiaries at GJH are to be made available to CMO's office for the purpose of raising bills.**

Further, the specimen copies of proforma for in-patient & out-patient treatment are enclosed herewith for your information and necessary action.
