Sub. Annual Indexation factor for ARR computation and indexation of SOR by BOT operators under Tariff guidelines., 2019 for **BOT operators** previously governed by 2005 Tariff Guidelines) with reference to variation in Wholesale Price Index (WPI)

TAMP vide reference 1<sup>st</sup> cited communicated the Annual indexation factor for BOT operators and informed all **BOT operators** to take appropriate action accordingly.

- (i) Annual Indexation of 1.74% (at 100% of the WPI Variation) for computation of indexed ARR as per Clause 2.8 of the Tariff Guidelines, 2019 for tariff revision proposal filed in the year 2024-25.
- (ii) Annual Indexation of 1.04% (at 60% of the WPI variation) for indexation of SOR to arrive at the indexed SOR by BOT operators as per clause 2.12 of the Tariff Guidelines, 2019.
- (iii) The indexed SOR shall be effective from 1<sup>st</sup> May, 2025 and shall be valid till 30<sup>th</sup> April, 2026.
