
It is hereby informed that the Visakhapatnam Port Authority (VPA) has awarded the project for Development and Mechanisation of the Existing East Quay 6 (EQ-6) Berth on a Design, Build, Finance, Operate and Transfer (DBFOT) basis to M/s. Eversun Marine Ports Private Limited (EMPPL), with effect from 26.07.2025, for a period of 30 years.

Pursuant to the Concession Agreement, M/s. EMPPL has commenced commercial operations at EQ-6 berth with effect from 07.08.2025. The facility is now fully operational and equipped to handle various cargoes in compliance with applicable statutory and safety requirements.

All stakeholders and port users are hereby requested to take note of the commencement of operations at EQ-6 berth and utilize the facilities being provided by M/s. EMPPL for their cargo handling requirements.

For smooth and uninterrupted operations, users are advised to liaise directly with M/s. EMPPL for operational matters, while VPA shall continue to extend necessary support in accordance with the provisions of the Concession Agreement.
