Sub: Reporting of Accidents / Incidents to Statutory Authorities and Port Safety Officer – Req.

It has been a well-established practice and statutory requirement to report accidents / incidents by the work section (Process Owner) to various agencies like Statutory Authority, Police / Insurance, Port Safety Officer etc., on relevant statutory formats stipulated under various Labour Acts / Regulations.

Of late, it is learnt that the work spot in-charge officers are reporting the cases concerned very late. The time of reporting is very much counted and essentially shown as and when demanded by the Statutory Authority, since it is a mandatory requirement.

The same was already intimated to all the Departments vide reference cited above and earlier Dy. Chairperson circular Dt. 29.04.2019 is enclosed herewith for reference and compliance. But the information in connection with Accidents / Incidents are not being received to the Port Safety Officer in time resulting the preparation of investigation reports duly analyzing the root causes is being delayed in such cases.

In the light of the above, once again, all the in-charge officers of work sections are directed to comply with the statutory reporting as and when Accidents / Incidents occur (including Near-misses) in the prescribed format (FORM - XII) to the Port Safety Officer. The contact mobile number and office numbers are furnished hereunder for communication and the same is to be displayed at respective work locations / office premises by the in-charge officers.
