II. ELIGIBILITY

Qualification: Engineering / Diploma Examinations passed (in the years 2022/2023/2024 only) and who have registered in MHRD NATS Portal (which is mandatory.

Candidates, who have previously undergone Apprenticeship or presently undergoing Apprenticeship Training or presently in employment elsewhere being registered for Apprenticeship Training under Apprentices (Amendment) Act, are not eligible to apply.

III. MINIMUM EDUCATIONAL QUALIFICATIONS:

Category — i) Graduate Apprentices:

- A Degree in Engineering or Technology granted by statutory University.
- A Degree in Engineering or Technology granted by Institutions empowered to grant such degrees by an Act of Parliament.

<u>Category — ii) Technician (Diploma) Apprentices:</u>

- A Diploma in Engineering or Technology granted by a State Council or Board of Technical Education established by a State Government in relevant discipline
- A Diploma in Engineering or Technology granted by a University in relevant discipline.

- IV. AGE: Age limit will be followed as per Apprenticeship rules.
- V. <u>RESERVATION OF VACANCIES:</u> Guidelines under Apprentices Act Reservation for SC/ST/OBC/PWD will be followed. The aspirants who are claiming reservation under SC/ST/OBC/PWD shall provide certificate as per Government standard format, failing which their claim for reservation will be considered as 'General' category only. If BC candidates claim in OBC category, they should furnish OBC certificate as per the Government prescribed (OBC) format from the certificate issuing Authority / Tahsildar (if authorized).

VI. MINIMUM PHYSICAL STANDARDS:

As prescribed in Clause 4 of the Apprenticeship Rule 1992 and amendments thereof, if any.

VII. DURATION OF TRAINING:

The duration of Apprenticeship training will be for a period of ONE year as per Apprentice (Amendment) Act 1973.

VIII. PREVIOUS TRAINING/EXPERIENCE:

Candidates who have already undergone or currently undergoing Apprenticeship under Apprentices (Amendment) Act 1973 or having one year or more experience are not eligible to apply.

IX. SELECTION PROCEDURE:

MODE AND CRITERIA OF ENGAGEMENT OF APPRENTICES:

- A. Engagement of Graduate and Technician Apprentices will be purely made on merit basis of aggregate marks obtained by the candidates in Graduate and Diploma respectively.
- **B.** Preference will be given to the children of VPA Employees i.e. the children of deceased employees / medically invalidated & superannuated employees / serving employees respectively.
- C. The final rank list would be prepared according to categories General/SC/ST/OBC after certificate verification comprising of ADT BoAT (SR) and Officials Visakhapatnam Port Authority, Visakhapatnam, Andhra Pradesh.
