Sub. Indexation of Tariff caps fixed in the Reference tariff cases under 2013, guidelines for **PPP Projects** at the Major Port Authorities with reference to variation in Wholesale Price Index (WPI) – Reg.

Indian Ports Association vide reference 1st cited has communicated the Indexation of Tariff caps with reference tariff cases under 2013, guidelines for **PPP Projects** at the Major Port Authorities with reference to variation in Wholesale Price Index (WPI).

Accordingly, it is to inform that the indexation factors with reference to the variation in wholesale price index occurring between January 2025 and December 2025 is as follows.

- a). Indexation factor of 0.65% for computation of indexed ARR as per Clause 2.3 of the Tariff Policy for Major Port Authorities Act 2021 for the year 2026-27.
- b). Automatic annual indexation of SOR as per clause 2.8.1 of the Tariff Policy for Major Port Authorities Act, 2021 considering 60% of variation in WPI occurring between 1st January 2025 and 31st December 2025 is 0.39%.

The indexed Reference tariff shall be effective from 1st April, 2026 to 31st March, 2027.
