In continuation to this office earlier Circular reference 13<sup>th</sup> cited, it is to inform that IPA,vide letter correspondence dated 11.03.2026 reference14<sup>th</sup> cited has extended the rationalized tariff for Cruise Vessels for a further period of one year ie. from 01.04.2026 to 31.03.2027 and the details of which are as follows:

**I. Cruise Tariff:**

**a). Extension of existing Cruise Tariff.**

Financial year	Head Tax (USD)	Tariff for 12 Hours (USD)	Tariff beyond 12 Hours (USD)
2026-2027	6 per pax	0.085 per GT	0.0175 per GT per Hour

**II. Volume Discount (Pan – India Basis)**

**(a) Domestic Cruise Calls:**

From 26 to 35 calls per year – 10% rebate  
From 36 to 70 calls per year – 15% rebate  
Above 70 calls per year -20% rebate

**(b) International Cruise Calls:**

10% discount applicable after 10 calls.
