In this connection, it is to inform the tollowing comments on the subject mentioned above, is furnished here under for giving a suitable reply to the Hon'ble Member of Parliament.

In the beginning days, when there we ano affordable educational facilities within the vicinity of VPT, as a welfare measure, VPT has incorporated Visakhapatnam Port Educational Society with an objective to provide school education at affordable cost to the children of its employees. Over a period of time the strength of VPT employees has come down from about 7721 in the year 2000 bit to 3348 in 2018-19 and parallely several educational institutes have come up and the employees were also able to afford the cost of education elsewhere and the induction of employees children into Port Schools has come down heavily.

At present, Port Employees children studying in port schools is below 2% and whereas VPT is spending huge amount of Rs 4.91 crores per annum on port school staff salaries & other expenditure besides maintenance of buildings etc. At present there are 37 teaching & non-teaching staff working in Port Schools, out of which only 06 aided teaching & non-teaching staff were receiving grant from State Govt, and the expenditure on salaries, retirement settlements are on the remaining 31 unaided teaching & non-teaching staff were being incurred from VPT funds. Further, the Corporate Objective of the VPT is to develop the Port to the International standards and it is also spending huge amount for the developmental activities in and around the Port Area & Schools etc., under Corporate Social Responsibility

In this connection, it is submitted that duly taking the performance of the students admissions, the teaching & non-teaching staff retirements in the ensuing years, an administrative decision was taken to close the Godavari Port Primary & High Schools in phased manner initially with 1st and 6st class as and accordingly letters were also sent to the Principal Secretary to Govi. School Flucation, AP, Amaravathi and to the Local Educational Authorities.

It is also to inform that the Principle Secretary to Government School Education, A.P. stated that, if due to non-filling up of vacant aided post due to the Policy of the Government, an aided school is unable admit new children or continue to provide education to those children who are studying in that school, the Children may without any hindrance be admitted or transferred to the nearby Government or Municipal Schools. Accordingly, admissions for 1st class 1000 2018-19 were stopped, under intimation to educational authorities vide this office letter dt.15.05.2018 (copy enclosed) and also separate letter was addressed to DEO, Vs.) vide this office letter dt.13.09.2019 (copy enclosed) stating the reasons for stopping admissions in 1st class during 2018-19.

Further, it is also to inform that during Aug'19, on the representation of Sri K.K.Raju, Co-ordinator, Visakha Norin Constituency, YSR Congress Party, the District Educational Officer Visakhapatnam vister is letter No.DEO/1057/2019-SA(MIEXM), dt.19-08-19 has requested to take-up the admissions in all classes in both Port Primary & High Schools until further orders. But, the DEO was informed vide VPE Society letter No.VPES/79/PGS. /Sgp/19/115, dt.1. 05 2019, that due to the decrease in staff on retirements especially during 2019 liselr 8 gloed and unaided staff members were retiring from port schools and as on today there are only three unaided teachers working in Port Primary School for 3 classes (I, e.3.4, & 5 ck ases) and out of which one unaided teacher is retiring in 4/2020 besides shortage of teachers in Port High School-1(Godavari) due to retirements and hence, it is to inform the analy not be possible to run the Primary School without sufficient staff as such it is not possible to take the admissions.
